Believe and Read

Last week K-2 started the Believe and Read reading program we are using through Groves Literacy Organization. We have a coach onsite every Friday working with teachers to ensure the capability of teaching the program. The program's initiation has not been perfect, but the teachers are asking our coach good questions to understand the different parts best. Learn more about Believe and Read Here.

Coaching

This year we have teamed up with Northshore Coaching to have an educational coach work with teachers each month to help them reach their teaching goals. Our coach works with 3 teachers each visit and will be here monthly through February. A CSCOE grant covers this coaching.

Virtues In Practice (VIP)

We started our VIP program this month. Each month we will focus on a different virtue. Each week of the month, we introduce a different piece. Week 1, the virtue. Week 2, a saint that exemplifies the virtue. Week 3, how to practice the virtue in school. Week 4 how to practice the virtue at home. Students can nominate for the VIP award.

NWEA Testing

Students start NWEA Growth assessment on September 26. Teachers use this data to help guide teachers with the instruction needed for each student.

Since our last board meeting, we have had 1 new student enroll in preschool, 7th grade and 8th grade. 1 additional student touring to start in preschool.

Kindergarten is full, any future inquiries will be placed on a waitlist

7/8th grade are full, any future inquiries will be placed on a waitlist and discussed on a case by case basis. The middle school classes are still blended for all classes except Math and English.

*** We need to look at and discuss a plan for next year's 5th/6th grade. Current Enrollment would mean there are 26 students in the class. Middle school teachers have expressed a concern about room size and space. Current layout is difficult for the 21 students they have. What is our "Cap" from an enrollment standpoint? Do we split more classes but not all? Middle School teachers do like some blending as it allows the older class to be leaders to the younger blended class. Also helps with friendship dynamics.

Community Building Events:

Hosted our 1st Family fun night on Monday at Big Stone Mini Golf. Appx 50 people in attendance.

Grade level parent coffees are being hosted following Mass. Parents are invited to attend on the day that their students' class leads Mass. Myself, Becky and Father attend.

Finance -

The 2022-23 Financial Plan as of March 2022 assumed 57 preschool students and 140 K-8 students. This was due to our new "Save Your Spot" registration program - parents saved spots in winter and then withdrew over spring/summer.

We ended up with 57 preschool students and 122 K-8 students. As a result, our budget needed to be rebalanced. We did this by:



- 1.) Increasing our fundraising goals by approximately \$27,000
- 2.) Increased our "Other Income" by \$10,000 to more accurately reflect Pennywise income
- 3.) Reduced Continuing Ed by \$9,000
- 4.) Reduced Equipment Purchases by \$10,000
- 5.) Reduced salary estimates by \$20,000 due to lower staffing needs

Gretchen motioned to approve budget. Second Ginger. Passed.

Fundraising

\$15,000 grant for Help-A-Student. Ambassador donations have recently come in. Alumni happy hour at Incredible festival.
